Callers of Islam and Khilafah are Ummah's Friends not Enemies

On 20th February 2016, under the title "Court set up to try nation's 'enemies' holds first hearing" the English language Dawn Newspaper reported on its webpage that a special court approved by Parliament under the "National Action Plan," which is no more than a US plan to suppress Islam, will be held on 22 February 2016 for the trial of twelve members of banned outfit for distributing pamphlets inciting "hatred."

Yes, the struggle between truth and falsehood has existed since when Allah (swt) created Adam (as) and Iblis and it will continue until the Day of Resurrection, thus the people of falsehood against Lut (as) rejected his eminence whilst proclaiming as described in the Quran, ﴿وَمَا كَانَ جَوَابَ قَوْمِهِ إِلَّا أَنْ قَالُوا﴾ **"The answer of his people was only that they said, "Evict them from your city!
