

## Press Release

## The Crime of Aqaba will Only Increase the Authority and the Regimes Shame and Disgrace, And Will Increase the Enemy's Transgression and Criminality

﴿إِنَّ هُولَاءِ مُتَبَّرٌ مَّا هُمْ فِيهِ وَبَاطِلٌ مَّا كَانُوا يَعْمَلُونَ ﴾

"Indeed, those [worshippers] - destroyed is that in which they are [engaged], and worthless is whatever they were doing." [Al-A'raf: 139]

While the blood of the Nablus martyrs has not yet dried up, and the wounded are still covered in their own blood, the delegation of the Palestinian Authority (PA), which now sees treason as a point of view but rather as a way of life, meets with the greatest Jewish criminals under the auspices of the head of kufr and international colonialism and the protector and sponsor of the Jewish entity, America, and in the presence of witnesses of treason, the two regimes the Jordanian and the Egyptian!

These criminals have come to lack all values and trample all the red and yellow lines and even the blood lines. Indeed, by Allah, they do not possess the protectiveness of the days of ignorance, so they did not respect our Deen, kinship, or covenant! Who would accept to sit with the murderer of his people, coordinate plans with him, and conclude agreements with him against his people, except for a traitor and an agent?! And who is the one who supports his enemy against his people and considers their jihad as violence that must be stopped, except for a sinful traitor?! Shame and disgrace are for them in this world, and woe and humiliating punishment in the Hereafter. What they do is evil.

The joint statement affirmed, and what was hidden from it is greater, the commitment to previous agreements, the commitment of the two parties to reduce escalation and prevent further violence, and the emphasis on the historical status of Jerusalem. And the Jewish entity is committed not to discuss the establishment of settlement units for a period of four months and not to approve any new outposts within six months. And that the meeting takes place again in March in Sharm El-Sheikh to confirm the achievement of the aforementioned goals.

In light of this, we are interested in emphasizing the following matters:

- 1- The meeting with the Jewish entity at a time when its hands are dripping with blood as a result of its crimes in Nablus, Jenin, and elsewhere is considered a summit of criminality, recklessness, betrayal, and conspiracy against the people of Palestine with premeditation and malicious intent. ﴿يَا أَيُّهَا الَّذِينَ آمَنُوا لَا تَخُونُوا اللَّهَ وَالرَّسُولَ وَتَخُونُوا أَمَاثَاتِكُمْ وَأَنْتُمْ تَعْلَمُونَ (O you who have believed, do not betray Allāh and the Messenger or betray your trusts while you know [the consequence]" [Al-Anfal: 27]
- 2- Relying on the commitment of the Jewish entity to the agreements is a political absurdity. Rather, it is subordination itself. Which sane person does not try what is experimented twice, so

how about it being experimented for thirty years?! ﴿ وَالْ كُلُمُ اللهُ "Is it not [true] that every time they took a covenant a party of them threw it away? But, [in fact], most of them do not believe" [Al-Baqara: 100]

- 3- The Palestinian Authority's commitment to reducing escalation and preventing violence, in addition to its crime of describing jihad as violence, means only the pursuit and arrest of the mujahideen and the increase in the pace of security coordination in pursuing them, while the criminality of the Jews will continue without oversight or accountability. The statements of Hanegbi are the best evidence, which confirmed that there is no settlement freeze or any change in the situation of the sacred mosque and no restrictions on the activity of the Jewish army anywhere. What is happening tonight in the town of Hawara is the best witness and evidence.
- 4- Talking about preserving the historical status of the sacred places does not mean stopping the Jews' incursions into Al-Aqsa Mosque, nor their preventing and harassing the worshipers. Rather, this criminal entity will continue to seek to impose the spatial and temporal division, as it did during the previous government, which was declaring its preservation of the historical status, while the incursions and attacks on the mosque increased on worshipers and those in l'tikaf. This agreement is an authoritarian Jordanian-Egyptian green light for this entity to continue its crimes and attacks, which was confirmed by Hanegbi in his aforementioned statement.
- 5- The talk about opening channels of communication and strengthening coordination between the two parties only means that the PA will provide more "venerable" security services to the Jewish entity. The follower realizes that there are no political solutions because America is preoccupied with more important and heated files, and that the aim of these meetings is nothing more than the calm that comforts America from the trouble of this thorny file.

So, disavow from them and their policies, and direct your appeals to the living forces in your Ummah, may your cries touch the ears of men such as Al-Mu'tasim and Salah ud-Din, and he will mobilize the Muslim armies to eradicate the Jewish entity and their henchmen, from their roots and relieve the Ummah from their evils. Which will happen soon, Allah willing, so trust in Allah's promise and trust in your Ummah, and Allah is with you and will reward you for your good deeds.

"O you who have believed, if you support Allāh, He will support you and plant firmly your feet \* But those who disbelieve - for them is misery, and He will waste their deeds" [Muhammad: 7-8]
